# HOUSING ASSISTANCE PROGRAM INFORMATION

# VA Aid and Attendance Benefit

For veterans or their surviving spouses living in California, assistance for senior living programs may be available through the California VA. These benefits are in addition to a monthly pension, not in place of a pension. Eligibility for additional support under the VA benefits program requires the meeting one or more of the following conditions:

- The aid of another person to perform normal tasks of everyday living, including feeding, bathing, dressing and attending to medical needs.
- Disabilities that have resulted in the need to remain bedridden outside of any prescribed course of convalescence or treatment.
- Currently a patient in a nursing home due to physical or mental challenges
- Eyesight at a corrected acuity of 5/200 or less in both eyes or limitations in concentric correction to five degrees or less of the visual field.

As of 2020, the VA Aid and Attendance Benefit can provide up to \$1,788 per month for veterans, \$1,149 per month for a surviving spouse of a veteran, or \$2,120 per month for couples in need of assistance.

# **California State Department of Aging**

The California State Department of Aging is a state government agency dedicated to the well-being of seniors. ### Housing Authority of the County of Riverside

Low-income housing for adults age 62 and adults with disabilities is available through the U.S. Department of Housing and Urban Development (HUD). "Low income" is typically considered to be less than 50 percent of the median area income, but some programs have exceptions. If you are experiencing homelessness and need housing, help is available through Home Connect. Call <u>1-800-498-8847</u> to connect with a staff member from an agency in Riverside County who can help you start the process to secure housing.

Our Housing Support Program also helps secure housing for eligible <u>CalWORKs</u> customers who are experiencing homelessness or are at-risk of homelessness. The program offers several benefits including housing outreach and placement, hotel/motel vouchers, and rental assistance. ### **Riverside University Health Systems**

Individuals and families living in homelessness or at risk of experiencing homelessness can find support through our department and partnering agencies. Behavioral Health Home Connect and can assist anyone experiencing homelessness or at risk of losing their home. If you need help, just call (800) 498-8847.

Our partners with Housing, Homelessness Prevention and Workforce Solutions (HHPWS), which includes the Housing Authority, offer access to affordable housing programs and job training services. #### Cash Assistance (CalWORKs)

CalWORKs is designed to give families with children a way to meet their basic living needs. We want to help families in times of hardship enter or re-enter the workforce and become self-sufficient. For working families, the CalWORKs program provides:

- Temporary cash assistance to eligible families with low or no income
- Education
- Employment and job training programs
- Childcare
- Transportation
- Work expenses
- Counseling

You may be eligible to receive cash assistance if:

- You have a child in the home who has a parent that is:
- Deceased
- Unemployed
- Not living in the home
- Disabled
- You are a relative taking care of a child
- You are a pregnant woman with no other children.

The amount of cash assistance a family can receive depends on the number of people who are eligible and the amount of income they receive. After you apply, your Eligibility Technician (ET) will go over all of the eligibility requirements with you during the interview.

Once every 12 months, eligible families qualify for sixteen non-consecutive days of temporary homeless assistance and a one-time payment for permanent housing assistance. Speak to your ET for more information. If you are homeless or at risk of experiencing homelessness and need housing assistance

# Hotel/Motel Vouchers

If you are experiencing homelessness, hotel/motel vouchers can help. We provide hotel/motel vouchers to individuals who are receiving cash aid through CalWORKs for up to 30 days.

### **Rental Assistance**
